## What is this product?

### TYPE

This product is a sub-fund of BNY Mellon Global Funds, plc an open-ended umbrella type investment company with variable capital, organised as an Undertakings for Collective Investment in Transferable Securities (UCITS).

### OBJECTIVES

#### Investment objective

To provide long term capital growth through investment primarily, meaning at least 90% of its Net Asset Value (NAV), in a portfolio of equity and equity-related securities of small-cap companies that are located in countries which have the Euro as their unit of currency ("Euroland Countries").

#### Investment policies

##### The Fund will:

- invest in equity (company shares) and similar investments of smaller companies in countries that have euro as their currency (i. e. Euroland);
- exclude direct investment in issuers with material involvement in activities the Investment Manager deems harmful from an environmental and/or social perspective e.g., tobacco production. All issuers in which investments are made follow good governance practices;
- promote environmental and social characteristics pursuant to Article 8 of the Sustainable Finance Disclosure Regulation ("SFDR");
- invest at least 10% of its NAV in issuers that meet the definition of sustainable investment under SFDR; and
- be eligible to be held within the framework of a share savings plan ('Plan d'Épargne en Actions' or 'PEA') in France.

##### The Fund may:

- invest up to 10% of its NAV in collective investment schemes; and
- use derivatives (financial instruments whose value is derived from other assets) with the aim of risk or cost reduction or to generate additional capital or income.

### Benchmark

The Fund will measure its performance against S&P EuroZone SmallCap TR Index (the "Benchmark").

The Fund is actively managed, which means the Investment Manager has absolute discretion to invest outside the Benchmark subject to the investment objective and policies disclosed in the Prospectus.

While the majority of the Fund's holdings are expected to be constituents of, and have similar weightings to, the Benchmark, the investment strategy does not restrict the extent to which the Investment Manager may deviate from the Benchmark.

**Redemption and Dealing:** you can buy and sell your shares in the Fund between 9:00 and 17:00 (Irish time) on each business day in Ireland. Instructions received before 12:00 will receive the price quoted on that day. The minimum initial investment for this share class is EUR 5,000.

**Distribution Policy:** net income generated will be retained within the Fund and reflected in the value of your shares.

### PRODUCT TERM

This product does not have a maturity date. The board of BNY Mellon Global Funds, plc may terminate the Fund unilaterally in accordance with the fund documentation. In addition, your investment may be terminated unilaterally where you no longer comply with the conditions set out in the fund documentation including minimum holding requirements.

### INTENDED RETAIL INVESTOR

This product is intended for investors who plan to stay invested for at least 5 years and are prepared to take on a medium level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.

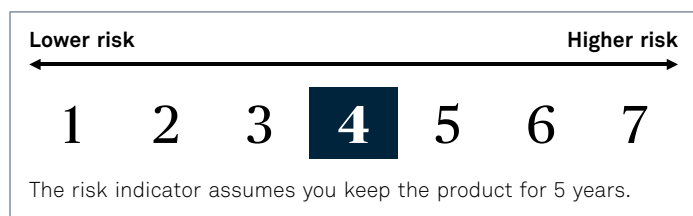

## What are the risks and what could I get in return?

### RISKS

## PERFORMANCE SCENARIOS

### COSTS OVER TIME

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
