What is this product?

TYPE

This product is a sub-fund of BNY Mellon Global Funds, plc an open-ended umbrella type investment company with variable capital, organised as an Undertakings for Collective Investment in Transferable Securities (UCITS).

OBJECTIVES

Investment objective

To achieve long term capital growth through investment primarily, (meaning at least two-thirds of the Fund's assets) in a portfolio of equity and equity-related securities of companies located worldwide, the majority of which shall be listed or traded on Eligible Markets located worldwide.

Investment policies

The Fund will:

- invest anywhere in the world;
- invest in company shares and similar investments;
- invest in companies of all sizes (e.g. small, medium and large companies) and in any industry (e.g. pharmaceuticals, financials, etc);
- limit investment in other collective investment schemes to 10%; and
- neither promote environmental and/or social characteristics pursuant to Article 8 of the Sustainable Finance Disclosure Regulation "SFDR" nor have sustainable investment as its objective pursuant to Article 9 of SFDR. Consequently, for the purposes of SFDR it is considered an Article 6 Fund.

The Fund may:

- invest in emerging markets;
- invest in bonds and other debt and debt-related securities with high credit ratings (i.e. investment grade bonds with a minimum credit rating of BBB- as rated by Standard and Poor's or similar agencies); and
- use derivatives (financial instruments whose value is derived from other assets) with the aim of risk or cost reduction or to generate additional capital or income.

Benchmark

The Fund will measure its performance against the MSCI AC World NR Index (the "Benchmark").

The Fund is actively managed, which means the Investment Manager has absolute discretion to invest outside the Benchmark subject to the investment objective and policies disclosed in the Prospectus. While the Fund's holdings may include constituents of the Benchmark, the selection of investments and their weightings in the portfolio are not influenced by the Benchmark. The investment strategy does not restrict the extent to which the Investment Manager may deviate from the Benchmark.

Redemption and Dealing: you can buy and sell your shares in the Fund between 9:00 and 17:00 (Irish Time) on each day which is a business day in Ireland and the U.S. Instructions received before 12:00 will receive the price quoted on that day. The minimum initial investment for this share class is EUR 5,000.

Distribution Policy: net income generated will be retained within the Fund and reflected in the value of your shares.

PRODUCT TERM

This product does not have a maturity date. The board of BNY Mellon Global Funds, plc may terminate the Fund unilaterally in accordance with the fund documentation. In addition, your investment may be terminated unilaterally where you no longer comply with the conditions set out in the fund documentation including minimum holding requirements.

INTENDED RETAIL INVESTOR

This product is intended for investors who plan to stay invested for at least 5 years and are prepared to take on a medium level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.

RISKS

PERFORMANCE SCENARIOS

COSTS OVER TIME
