## WHAT IS THIS PRODUCT?

**Type:** This product is a sub-fund of First Trust Global Funds ICAV (the "ICAV"), an open-ended investment fund established as an Irish collective asset-management vehicle with segregated liability between sub-funds. The product is an exchange-traded fund.

**Term:** This product is not subject to any fixed term. The ICAV is open-ended, however, the shares of the Fund or a class may be redeemed by the ICAV with notice to shareholders in the circumstances described in the Prospectus.

### Objectives:

- The fund seeks to provide investors with investment results that correspond generally to the price and yield of an equity index called the Dow Jones Internet Composite Index<sup>SM</sup> (the "Index").
- The fund invests primarily in equity securities that are included in the Index. The fund attempts to replicate, before fees and expenses, the performance of the Index.

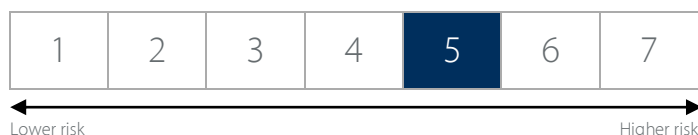

### Risk indicator

## WHAT ARE THE COSTS?

### Costs over Time
