What is this product?

Type

This product is a sub-fund of SEB High Yield, a Luxembourg open-ended common fund (FCP) with multiple sub-funds, which qualifies as a UCITS.

Term

The fund has no maturity date. The management company has the right to terminate the fund, more information can be found in the fund's prospectus.

Objectives

Investment objective The fund aims to generate long-term capital growth at a well-balanced level of risk.

Investment policy The fund is actively managed and invests worldwide, primarily in high yield corporate bonds from issuers in the United States and Europe.

The high yield (non-investment grade) bonds that the fund invests in have a credit rating of BB+ or lower by Standard & Poor's or an equivalent credit rating. The fund may also invest in other debt securities, including but not limited to investment grade bonds, debentures and money market instruments, contingent convertible bonds, as well as non-rated bonds that, based on internal analysis, are assessed to have a comparable credit rating to the defined high-yield range mentioned above. The fund may invest in contingent convertible bonds (CoCos) up to 20% of the fund's assets.

Investment decisions are based on in-depth fundamental analysis, aiming to identify investment themes and companies with attractive risk-return characteristics. The fund has the flexibility to adapt to changing market environments and may apply relative value strategies across issuers, sectors, and maturities. The fund may use derivatives for investment purposes, risk management, or to express market views. Credit risk and sustainability analyses are part of the investment process.

The return is determined by how much the fund's holdings increase or decrease in value during your holding period, which is mainly dependent on interest rates and the impact of future interest rate

developments on the fund's various fixed-income securities, primarily based on maturities and creditworthiness.

The fund promotes sustainability characteristics and is therefore classified as Article 8 according to the EU Sustainable Finance Disclosure Regulation (SFDR). The fund follows the management company's sustainability policy, which is available at www.sebgroup.com/funds.

Benchmark Bloomberg US and Euro High Yield ex Energy

The fund's index is the Bloomberg US and Euro High Yield ex Energy Index (the "Index"), a US and European fixed-income index covering corporate high yield bonds rated below investment grade and excluding the energy sector.

The fund's investment strategy does not seek to limit the extent to which the Fund's holdings may deviate from the Index. The investment team is therefore not constrained by the Index, which is solely used for performance comparison purposes.

Subscription and Redemption You can normally buy and sell units in the fund every Luxembourg bank business day, except December 24 and 31.

Distribution Policy The unit class is distributing.

Intended retail investor

This fund may be suitable for you who intend to keep your investment for at least 3 year(s), and who understands that the money invested in the fund can both increase and decrease in value. It is therefore not certain that you will get back all the invested capital. In order to invest in the fund, it is not required that you have any special prior knowledge or experience of mutual funds or financial markets.

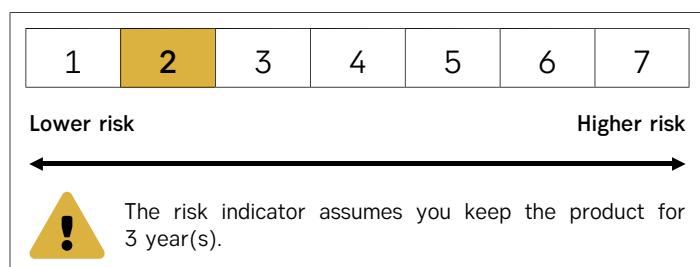

What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.

Performance scenarios

What happens if SEB Funds AB is unable to pay out?

According to law, the fund's assets may not be stored by the management company. Instead, each fund must have a specific depositary that takes care of the safekeeping of the fund's assets. In the unlikely event that the management company goes bankrupt, the management of the fund is taken over by the depositary. There is no arranged compensation or guarantee scheme for investors in the fund.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment. If the fund is included as part of another product, e.g. unit linked insurance, there may be other costs for that product.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment

amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the product's recommended holding period we have assumed the product performs as shown in the moderate scenario.
- 10,000 EUR is invested.

(*) This illustrates how costs reduce your return each year over the holding period. How long should I hold it and can I take money out early?

Recommended holding period: 3 year(s)

The fund has no requirement for a minimum holding period, but since it invests in fixed income, it is suitable for a short to medium term investment horizon. You should be prepared to hold your investment in the fund for at least 3 year(s). You normally have the opportunity to sell your fund units every bank business day in Luxembourg except December 24 and 31 without any extra fee.
