## What is this product?

**Type**

This is an open ended UCITS fund.

**Term**

The fund is established for an unlimited period. In certain circumstances the fund may be unilaterally terminated in accordance with legal requirements.

**Investment objective**

The fund aims to provide capital growth and income after fees have been deducted by investing in bonds issued by governments, government agencies, supra nationals and companies in emerging markets.

The fund is designed to participate in rising markets while aiming to mitigate losses in falling markets through the use of cash and derivatives. The mitigations of losses cannot be guaranteed.

The fund is actively managed and invests at least two-thirds of its assets in bonds, currencies and money market investments in emerging markets. The bonds are issued by governments, government agencies, supra-nationals and companies. The fund may also hold cash.

In exceptional circumstances during periods of high market volatility, the fund may hold up to 40% of its assets in deposits and money market investments in developed markets. In such instances, the two-thirds referenced above will be measured against the fund's assets excluding deposits and money market instruments in developed markets.

The fund may invest in excess of 50% of its assets directly or indirectly (including via credit default swaps and credit default swap indices) in bonds that have a below investment grade credit rating (as measured by Standard & Poor's or any equivalent grade of other credit rating agencies).

The fund may invest up to 15% of its assets mainland China through regulated markets (including the CIBM via Bond Connect or CIBM Direct).

The fund may also invest up to one-third of its assets directly or indirectly in other securities (including other asset classes), countries, regions, industries or currencies, Investment Funds and warrants (subject to the restrictions provided in appendix I of the fund's prospectus).

The fund may use derivatives with the aim of achieving investment gains, reducing risk or managing the fund more efficiently.

The fund is valued with reference to the net asset value of the underlying assets.

**Benchmark:** The fund does not have a target benchmark. The fund's performance should be compared against 50% JPM GBI-EM Diversified Index and 50% JPM EMBI Diversified Index. The comparator is only included for performance comparison purposes and does not have any bearing on how the investment manager invests the fund's assets. The fund's investment universe is expected to overlap materially with the components of the comparator benchmark. The investment manager invests on a discretionary basis and there are no restrictions on the extent to which the fund's portfolio and performance may deviate from the comparator benchmark. The investment manager will invest in companies or sectors not included in the comparator.

The comparator benchmark has been selected because the investment manager believes that the benchmark is suitable comparison for performance purpose given the fund's investment objective and policy.

The benchmark(s) does/do not take into account the environmental and social characteristics or sustainable objective (as relevant) of the fund.

**Currency:** The sub-fund currency is USD. The share class currency is EUR.

**Dealing Frequency:** You may redeem your investment upon demand. This fund deals daily.

**Distribution Policy:** This share class accumulates income received from the fund's investments, meaning it is kept in the fund and its value is reflected in the price of the share class.

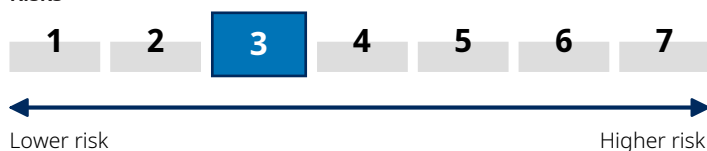

**Intended retail investor**

The fund may be suitable for investors who are seeking positive return over the medium to longer term (at least 3 years) by investing in an actively managed portfolio. The fund is intended for retail investors who have a basic investment knowledge and an ability to bear large short-term losses. This investment should form part of a varied investment portfolio. This fund is suitable for general sale to retail and professional investors through all distribution channels with or without professional advice.

## What happens if Schroder Investment Management (Europe) S.A. is unable to pay out?

The fund's assets are held in safekeeping by its depositary, so the fund's ability to pay out would not be affected by the insolvency of Schroder Investment Management (Europe) S.A. In addition, the fund's assets are segregated from the depositary's assets, which limits the risk of the fund suffering loss in case of default or insolvency of the depositary or someone acting on its behalf. However in the event of any loss, there is no compensation or guarantee scheme in place which may offset such loss.

## What are the costs?

### Costs over time

## How long should I hold it and can I take money out early?

There is no required minimum holding period for this fund but investors should not view this as a short term investment and you should be prepared to remain invested for at least 3 years. ## Other relevant information

The fund maintains a higher overall sustainability score than 50% JPM GBI-EM Diversified Index and 50% JPM EMBI Diversified Index based on the investment manager's rating criteria.
