What is this product?

Type

This is an open ended UCITS fund.

Term

The fund is established for an unlimited period. In certain circumstances the fund may be unilaterally terminated in accordance with legal requirements.

Investment objective

The fund aims to provide long term capital growth and income of the 3 Month Euribor + 4.5% per annum before fees have been deducted* over a five to seven year period by investing in a diversified range of assets and markets worldwide. The fund aims to provide a volatility (a measure of how much the fund's returns may vary over a year) of up to two-thirds that of global equities over the same period.

The fund is actively managed and invests at least two-thirds of its assets either directly or indirectly through derivatives or open-ended investment funds and ETFs in a wide range of assets including equities, bonds and alternative asset classes.

The fund may invest directly or indirectly (including via credit default swaps and credit default swap indices) in sub-investment grade bonds (being bonds with a credit rating below investment grade as measured by Standard & Poor's or any equivalent grade of other credit rating agencies). The fund may invest up to 20% of its assets in asset-backed securities and mortgage-backed securities. The fund may invest up to 20% of its assets indirectly in commodities. The fund may invest indirectly in alternative asset classes such as commodities or real estate through derivatives, investment funds or structured securities.

The fund may invest up to 100% of its assets in open-ended investment funds (including other Schroder funds). The fund may invest in another fund that charges a performance fee.

The fund may invest in money market investments and hold cash.

The fund may use derivatives, long and short, with the aim of achieving investment gains, reducing risk or managing the fund more efficiently.

The fund maintains a higher overall sustainability score than a bespoke asset weighted blend* of the MSCI World Index (hedged to EUR), MSCI Emerging Market Index (hedged to EUR), Barclays Global Aggregate Corporate Bond Index (hedged to EUR), Barclays Global High Yield excl CMBS & EMD 2% Index (hedged to EUR), ICE BofA US Treasury Index (hedged to EUR), JPM GBI Emerging Market Index - EM Local (hedged to

EUR), JPM EMBI Index EM Hard Currency (hedged to EUR), FTSE Global Convertible Bonds index (hedged to EUR), based on the investment manager's rating system. *The blend will evolve over time in line with the actual asset allocation of the fund.

The fund does not directly invest in certain activities, industries or groups of issuers above the limits listed under "Sustainability Information" on the fund's webpage, accessed via www.schroders.com/en/lu/private-investor/gfc.

Benchmark: The fund's performance should be assessed against its target benchmark, being to deliver 3 Month Euribor + 4.5% per annum and compared against the Harmonised Index of Consumer Prices and the MSCI AC World (Net TR) Hedged to EUR index. The comparator benchmarks are only included for performance comparison purposes and do not determine how the investment manager invests the fund's assets. In relation to the MSCI AC World (Net TR) Hedged to EUR index, the fund's investment universe is expected to overlap to a limited extent with the components of the comparator benchmark. The benchmark(s) does/do not take into account the environmental and social characteristics or sustainable objective (as relevant) of the fund. Currency: The sub-fund currency is EUR. The share class currency is EUR.

Dealing Frequency: You may redeem your investment upon demand. This fund deals daily.

Distribution Policy: This share class pays a quarterly distribution at a variable rate based on gross investment income.

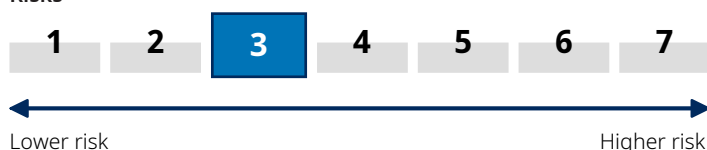
Intended retail investor

The fund will be suitable for investors who are more concerned with maximising long-term returns than minimising possible short-term losses. The fund is intended for retail investors who have a basic investment knowledge and an ability to bear large short-term losses. This investment should form part of a varied investment portfolio. Risks

We have classified this product as 3 out of 7, which is a medium-low risk class.

The fund is in this category because it seeks to provide rewards whilst limiting price volatility.

What happens if Schroder Investment Management (Europe) S.A. is unable to pay out?

The fund's assets are held in safekeeping by its depository, so the fund's ability to pay out would not be affected by the insolvency of Schroder Investment Management (Europe) S.A. In addition, the fund's assets are segregated from the depository's assets, which limits the risk of the fund suffering loss in case of default or insolvency of the depository or someone acting on its behalf. What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does.
