### What is this product?

#### Type

This is an open ended UCITS fund.

#### Term

The fund is established for an unlimited period. In certain circumstances the fund may be unilaterally terminated in accordance with legal requirements.

#### Investment objective

The fund aims to provide capital growth and income over a three to five year period after fees have been deducted by investing in a diversified range of assets and markets worldwide.

The fund is actively managed and invests directly or indirectly through derivatives in equities, bonds and alternative asset classes.

Bonds include government bonds, corporate bonds, emerging market debt, sub-investment grade bonds (being bonds with a credit rating below investment grade as measured by Standard & Poor's or any equivalent grade of other credit rating agencies), convertible bonds and inflation linked bonds. Investment in sub-investment grade bonds may be made directly or indirectly (including via credit default swaps and credit default swap indices). The fund may invest up to 20% of its assets in commodities. The exposure to alternative asset classes is taken through eligible assets as described in appendix III of the fund's prospectus.

The fund may invest indirectly in alternative asset classes such as commodities or real estate through derivatives, investment funds or structured securities.

The fund may (exceptionally) hold up to 100% of its assets in cash and money market investments. The fund may invest up to 10% of its assets in open-ended investment funds.

The fund may use derivatives, long and short, with the aim of achieving investment gains, reducing risk, mitigating losses in falling markets or managing the fund more efficiently.

The fund is valued with reference to the net asset value of the underlying assets.

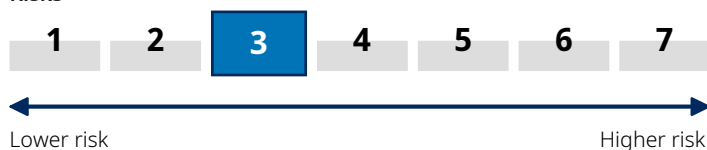
#### Intended retail investor

The fund is a medium risk vehicle that will be suitable for investors who are seeking long term growth potential, through investment in a diversified portfolio offering, exposure to a range of asset classes. The fund is intended for retail investors who have a basic investment knowledge and an ability to bear large short-term losses. This investment should form part of a varied investment portfolio. This fund is suitable for general sale to retail and professional investors through all distribution channels with or without professional advice.

#### Risks

## What happens if Schroder Investment Management (Europe) S.A. is unable to pay out?

The fund's assets are held in safekeeping by its depositary, so the fund's ability to pay out would not be affected by the insolvency of Schroder Investment Management (Europe) S.A. In addition, the fund's assets are segregated from the depositary's assets, which limits the risk of the fund suffering loss in case of default or insolvency of the depositary or someone acting on its behalf. However in the event of any loss, there is no compensation or guarantee scheme in place which may offset such loss.

## What are the costs?

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs.
