## WHAT IS THIS PRODUCT?

### Type

This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (SICAV).

### Term

This product has no maturity date. However, the manufacturer may decide to close the product under certain circumstances.

### Objectives

The Sub-Fund's investment objective is to achieve long-term capital growth by investing principally in a diversified portfolio of equities and/or debt securities of any kind including convertible bonds and Money Markets Instruments issued or guaranteed by sovereign, supranational and/or corporate issuers without any geographical restriction including emerging markets and emerging countries.

In order to achieve the investment objective, the Sub-Fund may invest up to 60% of its net assets in equities and/or convertible bonds.

Rated debt securities of any kind including Money Market Instruments, can represent 0% to 100% of the Sub-Fund's net asset.

The Sub-Fund will limit the investment in Unrated Securities with an equivalent Standard & Poor's credit rating of B- or higher as determined by the Investment Manager to 15% of the Sub-Fund's net asset.

Investment in High Yield and/investment grade bond (including but not limited to subordinated and junior debt, corporate hybrid and preferred shares), including Money Market Instruments, can represent, alone or in a combination of either one of them, from 0% to 100% of the Sub-Fund's net assets.

The Sub-Fund may invest up to 20% of its net assets in CoCos.

The Sub-Fund will limit the investment in debt securities issued by rated issuers with a Standard & Poor's rating, or equivalent rating agency, of CCC or lower to 10% of its net assets. For the sake of clarity, investments in defaulted securities are not envisaged nor allowed.

The assets may be denominated in currencies other than the Reference

Currency.

The Sub-Fund may also invest up to 10% of its assets in UCITS and/or other UCIs (including "ETFs qualifying as UCITS and/or UCIs").

The Sub-Fund shall only invest in UCITS and/or UCIs that apply entry and management fees (each of these fees) not exceeding 3% (three percent).

The Sub-Fund may invest indirectly in commodities.

Any reference to "indices" in the above paragraph has to be made to "Financial Indices".

The Sub-Fund may purchase or sell put and call options, financial futures and forward contracts, on financial indices, foreign currencies, government bonds and, in general terms, on transferable securities for hedging and/or investment purposes.

The Fund is actively managed and it has no reference benchmark.

The Sub-Fund has been categorized as a financial product falling under the scope of article 6 of the SFDR.

**Redemption and Dealing** Shares of the Fund may be redeemed on demand, with dealing normally on a daily basis.

**Distribution Policy** This Share Class does not pay dividends. Earned income is retained in the NAV.

### Intended retail investor

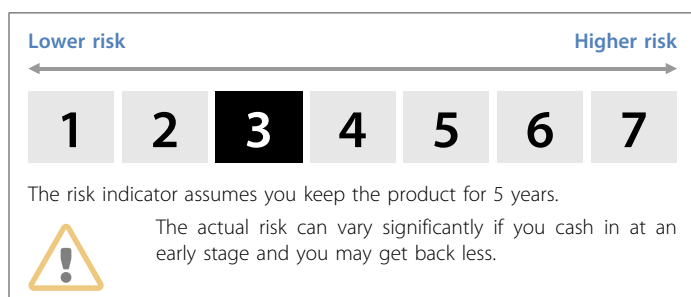
The fund is suitable for investors who seek the benefits of a diversified mix both debt securities both equities. It's also suitable for investors who are comfortable with and understand the risks of investing both in the equity and bond market. The investors must be able to accept temporary losses; thus the fund is suitable for investors who can, ideally, afford to set aside the capital for at least 3 to 5 years.

## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

### Risks

## WHAT HAPPENS IF PHARUS MANAGEMENT LUX S.A. IS UNABLE TO PAY OUT?

Pharus Management Lux S.A. is a société anonyme and has been appointed as management company of the Fund. The Fund is also a société anonyme and its assets are segregated from those of the Management Company. The Fund has entrusted the Depositary Bank with the safekeeping of its assets, which are kept separated from the Depositary Bank's assets. A default of Pharus Management Lux S.A. will therefore have no impact on the value of your investment in the product.

## WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 EUR is invested.

## HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

### Recommended holding period: 5 years

Due to the nature of the investment strategy, the suggested holding period is at least 5 years. However the investors will be able to close their investments on each redemption date.

## HOW CAN I COMPLAIN?

The purpose of the Complaints Handling Procedure of the Fund is to ensure that complaints are handled in a manner which is fair, objective and truth oriented. The following information shall be provided to ensure a prompt handling of the complaint:

- identity and contact details of the complainant;
- reason of the complaint; and
- where available, copies of any documentation supporting the complaint.

PHARUS MANAGEMENT LUX S.A. will send a written acknowledgement of receipt to the complainant within 10 working days after the receipt of the complaint, unless the answer itself is provided to the complainant within this period. PHARUS MANAGEMENT LUX S.A. shall seek to provide an answer to the complaint without undue delay and in any case within a period not exceeding 1 (one) month from the date of receipt of the complaint. If the answer cannot be provided within this period, PHARUS MANAGEMENT LUX S.A. will inform about the causes of the delay and the timescale to respond to the complaint.
