WHAT IS THIS PRODUCT?

Type: This product is a share class (UCITS ETF Acc) of a sub-fund (Factors Sustainable Japan Equity) of an investment company with variable capital (SICAV) under Luxembourg law (IndexIQ), Undertakings for Collective Investment in Transferable Securities (UCITS).

Term: Open-ended.

Objectives:

Principal assets traded:

Shares of mid- and large-cap companies whose registered offices and/or principal activities are in Japan, selected on basis of sustainable and responsible investing ("SRI") criteria combined with a non-market capitalization weighting method.

Investment strategy:

The Fund is passively managed meaning that it seeks to track, before the Fund fees and expenses, the performance of the Solactive Candriam Factors Sustainable Japan Equity Index (the "Benchmark") mainly by making direct investments in transferable securities representing most of the underlying components of the Benchmark (physical replication).

The Fund promotes, among other characteristics, environmental and/or social characteristics without having a sustainable investment objective.

The Benchmark and the Fund are constructed based on Candriam's Environmental, Social and Governance (ESG) proprietary approach that aims to select the best corporate issuers. The analysis of ESG aspects is integrated into the selection, analysis and overall assessment of companies.

Issuers are evaluated on the basis of an analysis of the business activities (how companies' activities address the key sustainable challenges...) and of the stakeholders (how companies manage material stakeholder issues including employees, environment...).

The Fund also seeks to exclude investments in companies which do not comply with certain internationally recognised standards and principles, or which are significantly exposed to certain controversial activities or which collaborate with countries considered to have highly oppressive regimes.

Finally, the analysis and selection process is also accompanied by active stewardship, in particular through dialogue with the companies and, as a shareholder, through voting at general meetings.

The Fund has not filed for the French SRI Label.

It is expected that the Tracking Error (the volatility of the difference between the return of the Fund and the return of the Benchmark) of the Fund under normal market conditions will remain below 0.30% per annum.

This product can be used as a core holding or a component of a diversified portfolio for investments with an investment horizon of 6 years. Investors should understand the product risks and only invest if they can bear potentially substantial losses.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



The risk indicator assumes you keep the product for 6 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

Risk Indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 4 out of 7, which is a medium risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity to pay you.

Be aware of the currency risk. If your reference currency is different from the product's currency, the yield of your investment will also be influenced by fluctuations, both up and down, in the exchange rate between these two currencies. In this case, the risk indicator above does not in fact take account of the fluctuations between these two currencies.

Other risk(s) materially relevant not included in the summary risk indicator: Concentration. Index replication. Sustainability.

This product does not include any protection from future market performance so you could lose some or all of your investment.

Performance scenarios

WHAT HAPPENS IF CANDRIAM IS UNABLE TO PAY OUT?

As the Funds' assets are held with the depositary, they are not part of the assets of Candriam in case of bankruptcy and cannot be seized by the creditors of Candriam. Nevertheless, investors run the risk to suffer a financial loss in case of the default of Candriam.

In case of default of the depositary, the risk of a financial loss is mitigated to some extent as the Fund's assets are legally segregated from the assets of the depositary.

WHAT ARE THE COSTS?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period: **6 years**

The selection of the recommended holding period depends on the underlying investments type as well as the level of associated risk (from high to low risk). For example, "equity" products (with a high level of risk) generally have a recommended holding period of 6 years (long-term period), "bond or money market" products (with a lower risk profile) have a shorter recommended holding period (generally between 2 and 4 years for bonds products or less than 1 year for money market products - medium-term/short-term period). "Mixed" products generally have a recommended holding period between 3 and 5 years, depending on the weight of the underlying instruments type. The recommended holding period for "Alternative-type" products is generally 3 years.

The investor may request for the redemption of its shares, at any time, under the conditions set out in the section "What are the costs?". A decision to shorten your holding period, compared to the recommended one, may increase the impact of potential fees on the performance profile.
