What is this product?

Type

UBS (Lux) Equity SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an open-ended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

The actively managed investment fund invests primarily in equities of companies in developed markets and emerging markets that support the United Nations Sustainable Development Goals (UN SDGs). This sub-fund promotes environmental and/or social characteristics but does not have a sustainable investment objective.

The objective of the sub-fund is to invest in companies that the portfolio manager believes align their products and services with the UN SDGs, such as climate change, air pollution, clean water and water scarcity, disease treatment and food security. The investment fund seeks to have a positive impact on human well-being and environmental quality. The investment fund is managed by a team specialised in sustainable investments. The portfolio manager has the discretion to construct the portfolio and is not bound by the benchmark in terms of shares and weighting.

The investment fund uses the benchmark MSCI AC World (net div. reinvested) for portfolio composition, performance comparison, ESG profile management and risk management.

The return of the fund depends primarily on equity market development and their exchange rate fluctuations, as well as dividend payments.

The income from this share class is reinvested (reinvestment). The exchange rate risk of the share class currency is to a large extent hedged against the currency of the fund.

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is suited to be acquired by the target client segments without any restriction of the distribution channel or platform.

Costs over time
