## What is this product?

### Type

The product is a UCITS sub-fund of an open-ended investment company with variable capital under the laws of Ireland.

### Term

This product is an open-ended fund without predefined maturity. You may request the redemption of shares generally on each valuation date. The company may, however, suspend the redemption if extraordinary circumstances appear to make this necessary, taking into account the interests of the investors. Further, the company may restrict the redemption. The product may be redeemed early in certain circumstances as set out in the sales prospectus. The 1C share class of Xtrackers DJE US Equity Research UCITS ETF was launched in 2025.

### Objectives

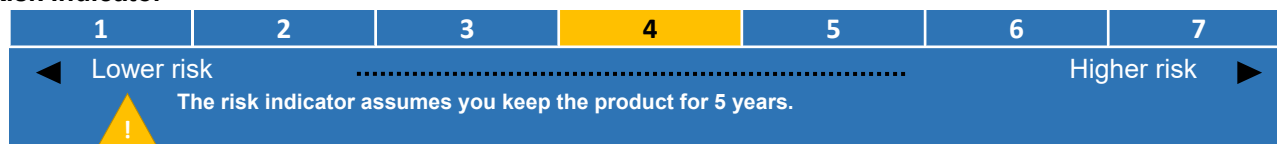
The fund is actively managed. The fund is not managed in reference to a benchmark. The fund promotes environmental and social characteristics and is subject to the disclosure requirements of a financial product in accordance with article 8(1) of Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial services sector. More ESG information is available in the sales prospectus and on the DWS website. **INVESTMENT OBJECTIVE:** The objective of the investment policy is to achieve a positive mid- to long-term investment performance through investments in the equity securities of large and medium-capitalisation companies in the United States (Equities). **ALLOCATION:** The sub-portfolio manager for the fund is DWS Investments UK Limited. DWS Investments UK Limited has appointed DJE Kapital AG (Discretionary Investment Advisor) to provide investment advice with regard to the composition of the fund's portfolio of equities (Proposed Allocation); the fund may also invest from time to time in other transferable securities, such as for the purpose of efficient portfolio management (together with Equities, Invested Assets). The composition of the Proposed Allocation and Invested Assets will be selected using a proprietary, research driven, bottom-up strategy with the primary aim of generating capital appreciation. In order to seek to achieve the Investment Objective, the Discretionary Investment Advisor will consider six quantitative and qualitative categories to determine a scoring model for each of the securities in the investment universe. The categories are valuation, momentum, safety and liquidity, sustainability, company meetings and (internal) analysts' recommendations. Typically, the 50 highest scoring securities are selected to comprise the Proposed Allocation, with a higher weighting typically assigned to the top 25 securities. The Proposed Allocation will be provided by the Discretionary Investment Advisor at least on a scheduled quarterly basis. The Sub-Portfolio Manager will assess the Proposed Allocation based on certain criteria and apply certain environmental, social, and governance (ESG) criteria to exclude companies which do not comply with certain standards as further described in the prospectus. In light of this, the Invested Assets of the fund may differ from the Proposed Allocation. **INVESTMENT POLICY:** The fund may employ techniques and instruments in order to manage risk, reduce costs and improve results. These techniques and instruments may include the use of financial contracts (derivatives). **FURTHER INFORMATION:** Certain information (including the latest share prices of the fund, indicative net asset values and full disclosure on the composition of the fund's portfolio) is available on your local DWS website or at [www.Xtrackers.com](http://www.Xtrackers.com). The return of the product is reflected by the daily calculated net asset value per unit and the distribution amount if applicable. The currency of the fund is USD. Returns and gains are not distributed but are reinvested in the fund. This fund is a sub-fund of Xtrackers (IE) plc for which the sales prospectus and the periodic reports are prepared as a whole. The assets and liabilities of each sub-fund are segregated by law. As a result, assets of one sub-fund are not available in the event of claims against or insolvency of another. More share classes may be available for this fund - please refer to the relevant section of the sales prospectus for further details. You are not permitted to exchange your shares in this fund for other funds of Xtrackers (IE) plc. The depositary is State Street Custodial Services (Ireland) Limited, Ireland. ## What are the risks and what could I get in return?

### Risk Indicator

## What happens if DWS Investment S.A. is unable to pay out?

The assets of the fund are kept separately from those of the management company, DWS Investment S.A.. An insolvency or default of the management company should not result in the fund suffering any financial loss in relation to its assets. On the insolvency or default of the depositary State Street Custodial Services (Ireland) Limited, Ireland securities held by the depositary on behalf of the fund should be protected but the fund may suffer loss in relation to cash and certain other assets which are not protected. Cash deposits of the fund deposited with other credit institutions may cause investors to suffer a financial loss if such deposits are not covered by any existing deposit guarantee schemes. Investment in the fund is not covered by any investor compensation or guarantee scheme.

## What are the costs?

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed: In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario. 10.000 USD is invested.

## How long should I hold it and can I take money out early?

### **Recommended holding period: 5 years. The product has no minimum holding period.**

This product has no required minimum holding period. The recommended holding period has been selected due to its investment strategy and because it is designed for a medium term investment horizon. It is expected that it will be possible to achieve the investment objective of the fund within this time frame. You may request the redemption of shares generally on each valuation date. No fees or penalties will be charged by the company for any such transaction.

There is no change on the risk return profile when you redeem your shares early.
